## Featured Speakers

**Joy Airaudi & Jessamyn Tracy**, of the Stalking Resource Center, work in partnership with The National Center for Victims of Crime and the U.S. Department of Justice Office on Violence Against Women. For the last 10 years, the Stalking Resource Center has been committed to providing training and technical assistance to increase awareness of and enhance the response to stalking throughout the United States as well as in other countries. The Stalking Resource Center (SRC) provides multiple services including training, technical assistance, a web site, and an information clearinghouse.

**Cynthia Fraser** is a Technology Safety Specialist for the National Network to End Domestic Violence (NNEDV), Safety Net Project. Through training, technical assistance, and policy advocacy, she addresses the impact of technology on survivors of stalking, domestic and sexual violence. She has 18 years of experience working to end violence in the US and Canada. Cynthia uses her experience with database, surveillance, communication, and assistive technologies to promote policy and practice that prioritizes safety, accessibility, and privacy rights for all survivors of violence.

**Chris Casto** currently serves as a Sergeant in his 19th year with the West Virginia State Police. He oversees The Digital Forensics Unit, Internet Crimes Against Children (ICAC) Unit and the West Virginia Cyber Crime Cooperative (WV3C), all of which address high tech crime investigations. Sgt. Casto is the Deputy Director of ICAC and has been involved in forensics and the investigation of white-collar crimes for over 15 years.

**Marsha Kisner** serves as the Rural Project Coordinator for WV FRIS. She has worked with victim advocates to develop Sexual Assault Response Teams (SARTs) in rural areas in WV. Ms. Kisner has a B.S. in Psychology/Criminal Justice. She has worked in a Prosecuting Attorneys Office and as an Information Technology Specialist for the National White Collar Crime Center.
