### FEATURED SPEAKERS

**Meg Garvin, M.A., J.D.**, is the executive director of the National Crime Victim Law Institute (NCVLI) and a clinical professor of law at Lewis & Clark Law School. Ms. Garvin is recognized as a leading expert on victims' rights. She has testified before Congress and the Oregon Legislature on the current state of victim law. She serves on the Legislative & Public Policy Committee of the Oregon Attorney General's Sexual Assault Task Force, co-chairs the Oregon Attorney General's Crime Victims' Rights Task Force, and is a Board member of the Citizens' Crime Commission. She is the recipient of the 2012 Crime Victims First-Stewart Family Outstanding Community Service Award. Prior to joining NCVLI, Ms. Garvin practiced law in Minneapolis, Minnesota and clerked for the Eighth Circuit Court of Appeals. She received her Bachelor of Arts degree from the University of Puget Sound, her Master of Arts degree in communication studies from the University of Iowa, and her J.D. from the University of Minnesota.

**TK Logan, Ph.D.** is currently a Professor in the Department of Behavioral Science, College of Medicine and the Center on Drug and Alcohol Research at the University of Kentucky, with joint appointments in Psychiatry, Psychology and Social Work. She has spent the past 15 years researching issues relevant to violence against women. Her research and writings most recently have focused on protective order effectiveness and predictors of violations, partner stalking, human trafficking, health disparities of rural women with partner violence experiences and sexual assault within the context of violent intimate relationships. Dr. Logan is an author on approximately 100 research articles. She serves on the editorial board of the Journal of Interpersonal Violence and the Journal of Comparative Family Studies and is a consulting editor for Psychology of Women Quarterly. She serves as a grant reviewer for the National Institute of Drug Abuse, National Institute of Alcohol Abuse and Alcoholism, and other special emphasis panels for the National Institute of Health.

**Kris Bein** is the Assistant Coordinator for the Resource Sharing Project, where she provides training and technical assistance to state coalitions and rural rape crisis centers on sexual assault services, agency structure and capacity building. Ms. Bein has been a part of the anti-violence movement since 1995. She provided medical and legal advocacy to sexual assault survivors and institutional advocacy to law enforcement agencies, medical institutions, and a university in rural southern Illinois before coming to the RSP at the Iowa Coalition Against Sexual Assault. Ms. Bein holds a master's degree in Human Services, with specialization in Social Services Administration, from the University of Illinois.

**Victim Privacy—Why It Matters & What You Can Do**

*Meg Garvin, M.A., J.D., Executive Director of NCVLI*

Victim privacy is put at risk in criminal cases when subpoenas are issued for victims' medical, counseling and education records, diaries, Facebook pages, cellphones and more. Privacy is a key to victims' healing and moving toward becoming survivors. This session will discuss why privacy matters to survivors, the system, and how victims' rights can be used to protect privacy and enhance justice outcomes.

**KEYNOTE 2**

**A New Framework for Understanding and Assessing Stalking: Moving Forward**

*Dr. TK Logan, Professor, University of Kentucky*

Stalking is a risk factor for both lethal and non-lethal violence as well as increased risks of sexual assault, threats, economic harm and victim terror. This presentation will examine how current perceptions of stalking often are wrong and harmful and introduce a new framework for understanding and assessing stalking as well as describing five basic principles every stalking victim should know.

**A1.—Protecting Privacy in an Online Age**

*Meg Garvin, M.A., J.D., Executive Director of NCVLI*

This session will build upon the morning keynote. Attendees will discuss a myriad of practical strategies to protect victim privacy using victims' rights to oppose subpoenas and arguing to allow a victim to proceed by pseudonyms.

**A2.—Civil Protective Orders: Justice or Just a Piece of Paper?**

*Dr. TK Logan, Professor, University of Kentucky*

This session will look at the effectiveness of personal protection orders through consideration of three intensive studies that answer most of the concerns of victims, victim advocates and other professionals in the justice system. Protective order outcomes were assessed using victim self-reports, court data and key informants from the courts, law enforcement and advocates. The presentation will conclude with several recommendations to better identify victims safety risks and to improve the protective order process and effectiveness.

**A3.—Trauma-Informed Services**

*Kris Bein, Resource Sharing Project*

In this interactive session participants will learn the principles of trauma-informed services and how to apply the concepts to advocacy practice. Considerations will be given to questions like, "What are the individual and cultural factors that influence trauma?" and "How can advocacy support survivors with multiple victimizations and needs?" First responders will learn to create plans for incorporating the principles of trauma-informed services into their practice.
