# The Use of Expert Witnesses in Cases Involving Sexual Assault Kimberly A. Lonsway, Ph.D.

The purpose of this paper is to summarize existing knowledge on the use of expert witnesses in cases involving sexual assault. The focus is primarily on expert testimony that is provided for the prosecution in a criminal case discussing the general dynamics of sexual assault and common reactions of victims. This paper was written both on the basis of a literature review of published material and contributions provided by numerous experts in the field. Ultimately, it is expected that expert witnesses will be used increasingly in cases involving sexual assault and we must proceed carefully to insure that they serve in responsible ways that truly assist both individual victims as well as the criminal and civil court systems.

## Police Response to Violence Against Women

The "Bringing Sexual Assault Offenders to Justice", developed by IACP, will help officers generate stronger cases by reframing sexual assault crimes, providing tools to conduct perpetrator focused investigations and build an

understanding of victim behavior, such as delayed reporting, alcohol or substance abuse, and encounters that start out consensually, that can be used to support a sexual assault report. This video will also provide useful information detailing how perpetrators often have a history of unreported acts of sexual violence and may select victims with vulnerabilities to exploit.

#### **Supervisor Report Review Checklists**

The IACP created five violence against women Report Review Checklists to assist supervisors in ensuring that reports capture significant and comprehensive details and the totality of crimes that occurs in cases of sexual assault, cases involving strangulation, domestic violence and stalking. The checklists can also be utilized by first-responders as a training tool to highlight the specifics needed when completing reports, interviewing victims, and reflecting on whether pertinent information has been effectively documented.
